3. The above said officer is hereby stand relieved from CCO, Meerut w.e.f. today i.e. 05.01.2026 (A/N).

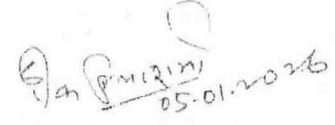
