ESTABLISHMENT ORDER No. 07/2026
DATED:21-03-2026

In pursuance of Establishment Order No. I/A/CCSC/07/2026 dated 13.03.2026 of the Additional Commissioner (CCA), Lucknow Zone, Lucknow, total 53 officers have been promoted as Inspector from the grade of Executive Assistant/ Stenographer Gr.I, on adhoc basis subject to the terms and conditions stipulated therein and total 19 officers have been allocated to Customs & CGST, Meerut Zone by CCA vide Establishment Order No. I/A/CCSC/08/2026 dated 16.03.2026.

2. It has been observed that out of these 19 officer, one officer namely Shri Mahendra Pal Singh (figuring at Sl. No. 38 of ET Order dt. 13.03.2026) is presently posted at DGHRD, New Delhi on loan basis, therefore, allocation of formation will be decided on his joining at Meerut Zone. The formations within Meerut Zone are to be assigned to remaining 18 officer.

3. Since AGT-2026 is expected shortly, therefore, the Competent Authority has decided to allocate the formations on a temporary basis to the said 18 officers in such a manner which keeps the disturbances to a minimum level and also simultaneously fulfils the administrative exigencies.

4. In view of above, the following allocation of the 18 officers among the different formations of Meerut Zone is hereby ordered with immediate effect and until further orders :
