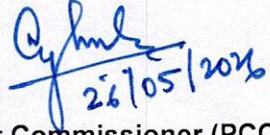
With the issuance of this order, all the representations received in the grade of Superintendent stand disposed of.

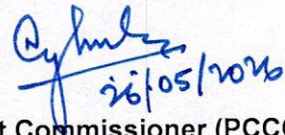
